

## ANADOLU SHIPYARD WEBSITE PRIVACY NOTICE

As Anadolu Deniz İnşaat Kızakları Sanayi ve Ticaret A.Ş. (Anadolu Shipyard), we place the highest importance on the security and confidentiality of your personal data while carrying out our activities. In line with the principles of honesty, transparency, and reliability — which constitute the core of our corporate culture — we would like to inform you, in our capacity as the “Data Controller,” about the purposes for which your personal data is processed, with whom it is shared, and your rights.

### 1. Legal Basis

**Article 10 of the Law No. 6698 on the Protection of Personal Data (“KVKK”)**, which entered into force on **April 7, 2016**, requires that the persons whose personal data is processed (used) (**referred to as the relevant persons in the KVKK**) to be informed by the “**Data Controller**” who uses this data. As a **Data Controller**, we have to prove that you have been informed about your personal data we will process.

### 2. What Personal Data Are Collected And Through Which Methods?

As **Anadolu Shipyard**, we collect your listed personal data through your visit to our website by digital means (**expressed as "automatic" method in KVKK**). Obtained personal data and the legal reason for obtaining them are listed below:

### What is the purpose and legal reason of your personal data obtained?

In the table presented below by **Anadolu Shipyard**, the purposes of personal data processing carried out within the scope of the activity in which the Privacy Notice is issued are detailed. Each personal data processing purpose is matched with the categories of personal data and the relevant legal reason relating to the purpose.

### **Are personal data transferred to others?**

Yes, we may need to transfer your personal data to our business partners, official authorities, auditors, lawyers, and financial advisors. However, such transfers are carried out only for specific purposes and with your knowledge. Accordingly, your personal data may be transferred to:

- Our contracted suppliers and service providers to offer you our services through our website, improve the quality of the services we provide, ensure technical infrastructure, and carry out support and control processes;
- Regulatory and supervisory authorities, as well as public institutions or organizations explicitly authorized by law to request personal data, in order to fulfill our legal obligations if required by competent authorities;
- Our legal consultants and mandatory parties are involved in legal proceedings for the purpose of managing legal affairs;
- Our group companies ensure tracking, continuity, auditing, and reporting of business processes.

### **What rights does KVKK give me?**

**KVKK** allows you to control your personal data such as:

(a) learn whether or not her/his personal data have been processed; (b) Request information as to processing if her/his data have been processed; (c) Learn the purpose of processing of the personal data and whether data are used in accordance with their purpose; (ç) Know the third parties in the country or abroad to whom personal data have been transferred; (d) Request rectification in case personal data are processed incompletely or inaccurately; (e) Request deletion or destruction of personal data

and **KVKK** provides many rights including but not limited to these. You can find all of these rights and details in **article 11** of the **KVKK**.

### **How can I exercise my rights?**

You may submit your requests regarding the rights set forth under the Personal Data Protection Law (KVKK) in writing to the address **Tersaneler Cad.
